

MINT Dues Process 2013-2015

Regular dues are set each year by the Board to cover the operating expenses of running MINT. For 2013, 2014, and 2015, regular dues are \$110. In an effort to help MINT members who are not able to pay the regular fee each year, for 2015 the Board is implementing an optional reduced rate that is set at 50% of regular dues (\$55.) The reduced rate code will be provided to all MINT members in the invitation to pay dues. This reduced rate is intended to help MINT members remain in MINT regardless of financial difficulties. The reduced rate is used completely on the honor system and does not require any permission or notification to the Board. MINT members are simply able to enter the code provided to have their dues set at the reduced rate. Any MINT member who is unable to pay the reduced rate dues will be encouraged to contact the MINT Treasurer to ask for a waiver, to be set at the amount the member is able to pay. The Board will evaluate the implications of the reduced rate policy for MINT's financial stability at the end of the 2015 dues collection period and decide whether or not continuing this policy is feasible and desirable.
